Purpose of Dairysafe:

To ensure dairy products produced in South Australia are safe for consumers by ensuring South Australia's dairy processing (regulated) entities comply with Australia's national food safety standards throughout the supply chain.

Position Overview:

The Chief Executive Officer (CEO) of Dairysafe plays a pivotal role in leading the organisation through its strategic directions as set by the Board.

Reporting to the Dairysafe Board, the CEO is responsible for aligning Dairysafe's activities with its core values and strategic priorities, delivering sustainability activities, fostering strong relationships with stakeholders, and ensuring the organisation's compliance with legislative requirements. The CEO will lead, develop, and support Dairysafe's workforce while promoting a culture of innovation and excellence in food safety regulation across the dairy supply chain from farm to processing.
